



Immediate Commitments (First 100 Days)

Reverse Greyhound Racing Ban

Reverse the decision on the 2029 ban to protect regional jobs, cultural values, rural sport, and the industry's integrity. **If reversal is not agreed, publicly commit to a full parliamentary inquiry** into the Tasmanian greyhound racing industry with agreed terms of reference (see Appendix A).

Appendix A Draft Terms of Reference

Inquiry into Greyhound Racing in Tasmania

Scope of the Inquiry

The Inquiry is tasked with investigating, reporting on, and making findings and recommendations in relation to the following areas:

1. **The Premier's announcement on the closure of Greyhound Racing in 2029 in Tasmania.**
 - I. Consider the economic impact of this decision on the greyhound racing community, rural and regional communities, racing clubs, trainers, and small businesses connected with and supported by the racing industry.
 - II. Consider the care and welfare of greyhounds affected by the rundown of the industry and closure over the next four years to 2029, and their future as a breed.
 - III. Consider the fairness of the announcement and its effect on the mental health of Tasmanians involved in the industry and those in jobs currently connected directly or indirectly to the rundown and closure of the industry.
 - IV. Consider the effect of this decision on the future of other racing codes in Tasmania.
 - V. Determine whether racing has a future in Tasmania.
2. **Review the funding agreement currently in force and the future.**
 - I. Consider the adequacy of current government funding of the industry and its contractual obligations out to 2029.
 - II. Review the obligation on government to allow the industry to properly plan for a future post-2029, independent of government funding control.
 - III. Examine other industry funding and regulatory models in Australia that may be used as templates for future independent financial governance.
3. **Review industry governance model.**
 - I. Examine other governance models for the industry in Australia.
 - II. Review and consider the appropriate model in the Tasmanian context.
4. **Additional matters.**
 - I. Any other matters arising in the course of the inquiry into the above areas and the racing industry in general that may be considered relevant to the good governance and running of racing in Tasmania.

As you are aware, the Government has announced it will phase out greyhound racing in Tasmania by June 30, 2029. This coincides with the expiration of the current funding deed, and the timeframe provides an opportunity to deliver a measured and staged transition that focuses on the welfare of participants and greyhounds, including an economic support package.

To ensure this transition is appropriately and effectively managed, we request that you commence work as soon as possible to develop a comprehensive plan to deliver all operational, animal welfare and integrity components of this process. Please initiate a working group of suitably qualified industry representatives and animal welfare experts to assist in this process. Please include any recommendations regarding the required resources at both Tasracing Pty Ltd, and your office, to responsibly map out the pathway forward.

As per the recent announcement, we will move to establish a Parliamentary Committee to provide accountability to the community during the transition period. It is our expectation that you would present your plan to this Committee and report on the progress of transitional arrangements quarterly, or as required.

Thank you, Commissioner, for your role in the delivery of our reforms to provide the Tasmanian racing industry with a modern, effective, and fit-for-purpose model of regulation and integrity.

Phase out of greyhound racing

Thank you for your letter dated 13 August 2025.

The *Racing Regulation and Integrity Act 2024* (Tas) provides a legislative pathway for my office to develop and oversee the delivery of the transition plan for greyhound racing, following your request to do so. My office will commence this work immediately. I attach a proposed outline plan for the transition, which will be finalised over the coming days, with a final document shared with you next week.

To support this work, I will shortly be convening a working group of suitably qualified industry representatives and animal welfare experts to support this work, including representatives of Tasracing, RSPCA Tasmania, veterinary experts and representatives from the greyhound industry and general community. I am presently finalising a terms of reference for this working group.

I also enclose an open letter to the Tasmanian community regarding the greyhound racing transition, and the role of my office in overseeing the plan and responding to matters of concern for the industry and general public. This open letter will appear in The Mercury, The Advertiser and The Examiner on Saturday, 23 August 2025. A follow up media release will be issued on Monday, 25 August 2025, and I will make myself available for any media enquiries that may arise.

A dedicated page on the Tasmanian Racing Integrity Commissioner's website and email address (greyhoundtransition@racingintegrity.tas.gov.au) are being established and will be available from Friday to receive any queries or complaints in relation to the transition.

Finally, I note that a Parliamentary Committee is being convened to provide accountability to the community during the transition. I will make myself available to this Committee and provide quarterly updates, or as required.



Phase out of greyhound racing

As you are aware, on 10 August 2025, the Tasmanian Government announced the phase out of greyhound racing by 30 June 2029.

Following this announcement, the Government formally requested that I, as Tasmania's Racing Integrity Commissioner, develop a comprehensive plan to deliver all operational, animal welfare, and integrity components of this transition.

The *Racing Regulation and Integrity Act 2024* (Tas) provides the legislative pathway for my office to do so, and this work has commenced.

To support this transition, I am convening a working group of suitably qualified industry representatives and animal welfare experts, including representatives of Tasracing, RSPCA Tasmania, veterinary experts and representatives from the greyhound industry and general community.

I would like to have an eminent member of the Tasmanian community, without any affiliation to racing, to sit on the working group. As this person will represent the views of the Tasmanian community, I would be grateful for any input into this particular role on the working group.

I will also be providing updates on a quarterly basis, or as required, to the Parliamentary Committee once established.

You may have seen my recent open letter to the Tasmanian community regarding the greyhound racing transition, and the role of my office in overseeing the plan and responding to matters of concern for the industry and general public. This open letter appeared in The Mercury, The Advertiser and The Examiner on Saturday, 23 August 2025 and in the Tasmanian Country on Friday, 29 August 2025 (a copy is enclosed). A follow up media release was also issued on Monday, 25 August 2025 (available [here](#)).

A dedicated page on the Tasmanian Racing Integrity Commissioner's website (<https://racingintegrity.tas.gov.au/greyhound-racing-transition>) and email address (greyhoundtransition@racingintegrity.tas.gov.au) have been established to receive any queries or complaints in relation to the transition.

Should you receive any queries from members of the greyhound racing industry, or community, please refer them to my office and I will respond as appropriate.

Number of dog races and starters in Tasmania




Wagering on Tasmanian dog racing


Tasmanian Government funding of dog racing





Dollars wagered on Tasmanian dog races per dollar of government funding






Dog race attendances per \$000 of government funding



FTE jobs ‘sustained’ per \$000 of government funding




Government funding per FTE job ‘sustained’





Government funding of dog racing as a percentage of gross state product, 2022-23





Net taxation revenue generated by dog racing per head of population, 2022-23




