Arriving at our Cellar Door, visitors will be enveloped in the beautifully designed high-end bar for a taste of our 8 different flavoured rums and an array of cocktails.



While inside, technology will pay a key role in the visitor experience. QR codes will link the visitors, highlighting the heritage of the buildings with an Augmented Reality adventure, available from their mobile phones. Multiple virtual worlds will take them back to see not

just the previous fabric, but other aspects that have never been seen before.

This fully immersive experience will deliver distillery tours to see how premium Tasmanian rum is made, history tours to understand what life was like for those who lived there and after dark paranormal experiences which guarantee that you'll see a spirit (in ghost or beverage form)!

New Norfolk Distillery's Willow Court Revitalisation Project will become a beacon for great architectural design and economic enhancement. Expansion into these historic buildings will create employment in a regional town that has historic generational unemployment. Jobs in hospitality, experiential tourism, manufacturing and the arts will enable more people to come out to New Norfolk and enjoy a unique visitor experience. This will be the world's only Rum Distillery in an asylum, this will increase the destinational appeal of New Norfolk as a whole.

Being adjacent to the Agrarian Kitchen, this will become a hub for people wanting premium Tasmanian beverages and beautiful food in a historic setting and with the Derwent Valley Arts Gallery inhabiting the Willow Court Barracks also there will be so much to do in the area.

The unique heritage architecture, award-winning craft spirits and scenic value of New Norfolk will combine to draw interest and increase visitation regionally to the Derwent Valley from Tasmania, Mainland Australia & Overseas.

Our vision sees the newly developed site as the home for rum in Tasmania. Not only will visitors be able to enjoy a sophisticated and award-winning Tasmanian Rum, they will have the opportunity to partake in a history tour and learn about the rich history of the Derwent Valley Region. Our use of technology with augmented and virtual reality will allow everyone to the use their phones to see the old buildings as they were. We have also engaged an artist to do a respectful heritage interpretation of life at the site and create a memorial for those who had lived there.

This extension will create 40 FTE positions during construction including 7 apprentices & 20



FTE positions upon completion. As our construction company has won National Awards in training we wish to follow in their footsteps.

Our Willow Court Revitalisation Project will assist in improving visitation to regional areas. As the worlds only rum distillery in an old asylum, this will be a unique building offering unique experiences. This will resonate with people globally as it will have such an offering that cannot be found elsewhere.

As this building is currently unused, except for paranormal tours, this construction project will allow more people to access the buildings at Willow Court, thus restoring the access to the public which has been previously stopped due to the closure of the site.

New Norfolk has a generational unemployment issue as well as some of the highest youth unemployment numbers nationally. It is our aim to change that. With our construction business we have won training awards for our investment in apprentices and their future, which we see as our community's future also. We plan to engage the local high school, New Norfolk High School, in their hospitality department channel people from school to a traineeship or apprenticeship in hospitality. We have also been speaking to MAS national about creating a distillery certificate and hope that comes to fruition in the future. We would love for New Norfolk to become a hub for aspiring distillers and help educate them in the ways of the still.

Our new facility will allow distilleries in Tasmania to access base neutral spirit that is currently available from South Australia or Victoria. This will improve the providence of the other gins in Tasmania and allow them to create a fully Tasmania product, elevating the distilling industry in Tasmania. Furthermore, the facility will have an in-house laboratory will provide alcohol analysis to beverage producers, this will be the only Tasmanian-based alcohol laboratory servicing producers on the island, eliminating freight costs and increasing



efficiency for beverage testing.

Dear Premier,

I am writing to you today to express my disappointment in the recent round of funding for the Tourism Innovation Grant.

As a Tasmanian and the owner and founder of New Norfolk Distillery I have been trying to secure grant funding for our project in Willow Court for four years with this being the fifth grant we have applied for. All the advice we have received from various points within the state government has been that the work we have done on the project and the project itself is of great value to the community. However, this is obviously not the case considering we can't secure any funding or assistance for this project. This is also the second time we have lost out to a publicly listed distillery, which is incredulous that they were even considered when they have access to external revenue outside the reach of smaller earning businesses. Our plans are much more progressed, and we have a building permit ready to go, which in contrast to these other projects makes our plans more achievable in a shorter timeframe. We have also spent almost \$500,000 on this project to get it to where it needs to be to be successful which indicates there is skin in the game from us.

Further to the above, the buildings at Willow Court were gifted by the State Government to the Derwent Valley Council over 20 years ago and they have been a burden to them ever since. Our project will create 40 jobs during construction and 40 jobs after it has been completed. It will transform these derelict buildings into a destination for the Derwent Valley due to the appeal of the site's numerous historic, cultural, and social aspects. In terms of innovation, we are the only rum focused distillery in Tasmania, and we have just won another national award at the Australian Rum Awards picking up a double gold medal for our Drone Riot Silver Spirit and a gold medal for our Voor Vader Dutch Cookie Liqueur.





This project would change the town of New Norfolk, it would make an impact in a place that has generational unemployment and some of the highest youth unemployment in the country. Our local community believe in this project as do many of your parliamentary colleagues. We are just amiss as to what we need to do to secure grant funding as this project is constantly overlooked.

Should we let the site succumb to history and leave it as the derelict place it is? Or should we walk away as many have done in the past? We feel as though this project will never become of significance to the Tasmanian Government if it remains overlooked and undervalued.

Any insight would be appreciated as this endeavour has taken up much of our time and resources and we don't know if it should just be laid to rest and we invest our time, money and effort elsewhere.


