Thank you for your letter of 17 February in which you provided me a copy of the Code of Conduct for Ministers and the Tasmanian Government Lobbying Code of Conduct.

In accordance with the requirements under the Code of Conduct, I wish to advise you that I do not have any direct conflicts of interest in relation to my portfolio responsibilities of Racing and Sport and Recreation. However, I do wish to alert you to the following matters in order to clarify any perceptions of a conflict arising from my Ministerial duties:

- I have formally resigned as Patron of the Carlton Park Surf Lifesaving Club and of the Oatlands Football Club, in order to ensure that there is no perceived conflict of interest in relation to my association with these clubs as potential recipients of public funding. I intend to remain a Member of both Clubs.
- I will also remain a Member of the Dodges Ferry Football Club and I intend to continue to personally sponsor the Mount Pleasant Cricket Club.
- I also intend to remain a Member of the Wakeful Club, a social organisation that supports women in the racing industry.

While I have no direct interests in the racing industry and am not a beneficiary, financial or otherwise, from participants in the industry, I make the following disclosures in order to be completely transparent:

POTENTIAL CONFLICTS OF INTEREST

Thank you for your advice of 20 February 2020 concerning the potential for your membership of various sporting and recreation clubs, and your extended family's interests in the racing industry to cause potential conflict or perceived conflict with your new Ministerial duties.

I agree with you that these interests do not give rise to an actual conflict with your Ministerial duties.

However, it is clearly sensible to establish a procedure to allow you to manage or avoid any specific actual or potential conflict of interest that may arise in your work as a Minister.

I have sought advice from the Secretary, Department of Premier and Cabinet (DPAC), who liaised with the Office of the Solicitor-General.

Given your membership of several sporting organisations, and your extended family's interests in the racing industry, it is prudent for you to be alert to any decision that comes to you as a Minister (a 'decision of concern') or to Cabinet for discussion and decision (a 'matter of concern') that directly affects a sporting or recreational club of which you are a member, or specifically affects your extended family's racing industry interests.

In either case, should a concern arise, you should declare a potential conflict of interest at that time and follow one of the procedures described below. Before initiating a procedure, you may seek advice from the Secretary, DPAC, or directly from the Solicitor-General, about the potential for a matter to be of concern.

Decision of Concern

- As soon as you become aware that you could be asked or required to make a decision of concern, you are to contact me, or my office, with details of the situation (including nominating a Minister to act on your behalf).
- o I can then arrange for formal notification to the nominated Minister to act on your behalf in relation to the matter, or for a period of time to allow a matter to be considered and a decision made.
- The nominated Minister is to be briefed appropriately by your office/and or departmental staff and can, if appropriate, make a decision for and on behalf of you as Minister for Sport and Recreation, or Minister for Racing.
- o I have attached a draft example of an 'Acting Minister Authorisation' template.



Matter of Concern

- o If you become aware of a matter of concern before a meeting of Cabinet, you are to inform me (or the Acting Premier) beforehand and you are to absent yourself from any part of the Cabinet discussion at which the matter of concern is discussed.
- o If during a meeting of Cabinet, you become aware that a matter of concern is being or is about to be discussed, you are to inform me (or the Minister chairing meeting at that time) as soon as you form that opinion. On being advised, the relevant chair will suspend the part of the business of the meeting that gives rise to the matter of concern, and defer its consideration to a suitable time at which you will ensure you are absent while the matter of concern is discussed.
- o In either case, any Cabinet Decision that records the deliberation of Cabinet for the matter of concern will record the fact that you disclosed the conflict, were not present and did not take part in making the Decision.

I remind you that Ministers are individually responsible for preventing conflicts of interest. Ministers must take reasonable steps to avoid, resolve or disclose any material conflicts of interest, financial or non-financial, that arise or are likely to arise, between their direct and indirect personal interests and their portfolio responsibilities. Should any conflicts arise in the future, the Code of Conduct for Ministers makes clear that you must declare such conflict of interest in writing to me as soon as possible after becoming aware of the conflict.

Should staff in your Office or departmental officers have any further queries concerning the management of actual, potential or perceived conflicts of interest that may arise, in the first instance they can contact Ms Kim Enkelaar, Director, Office of the Secretary, Department of Premier and Cabinet. Ms Enkelaar may be contacted by email at kim.enkelaar@dpac.tas.gov.au or by telephone on 6270 5654.

I have also provided a copy of this memorandum to the Secretaries of the Department of Premier and Cabinet and the Department of Communities Tasmania, and the Acting Secretary of the Department of Primary Industries, Parks, Water and Environment, together with a copy of your letter of 20 February 2020.

Further, I consider it prudent that you provide a copy of your letter dated 20 February 2020 to the General Manager, Office of Racing Integrity for information.



Dear Jane

Congratulations on your appointment as a Minister of the majority Gutwein Liberal Government; we have our mandate and will deliver our plan to secure Tasmania's future.

Over the last seven years we have demonstrated we are a disciplined, united and responsible Government. We have built the foundations for, and sustained, strong economic and jobs growth for our State, and we have demonstrated commitment, focus and drive to deliver a better future for Tasmania.

At the election we outlined our plan to secure Tasmania's future which will deliver the certainty Tasmania needs by:

- Making the decisions necessary to continue keeping Tasmanians safe and secure from COVID- 19:
- Delivering a more diverse and resilient Tasmanian economy to create jobs and help protect against future challenges;
- Securing the essential services all Tasmanians rely on; and
- Ensuring young Tasmanians can get the training, apprenticeships and jobs for their future here in Tasmania.

Included in our plan were a range of commitments and policies. It is my expectation that those commitments and policies that fall under your Ministerial responsibilities will be delivered in full and on time. For many of these commitments and policies it will be essential that you work closely and constructively with other Ministers to deliver the best outcomes for Tasmanians and drive our response to, and recovery from, COVID-19 in the short and long-term.

Additionally, delivery of the interim and final recommendations from the Premier's Economic and Social Recovery Advisory Council (PESRAC) will be critical as we continue to recover from the impacts of the COVID-19 pandemic. You should work with your Departments, and the Department of Premier and Cabinet (DPAC) as the recovery agency, to deliver the recommendations relevant to your portfolio(s).



It is my expectation that all Ministers will enable their Heads of Agency to further strengthen working relationships and deliver outcomes across Agency lines, to ensure the Tasmanian State Service is united in purpose and vision and puts Tasmanians at the centre of everything it does. I have tasked the Secretary, DPAC, to write to all Heads of Agency providing them with a full list of Ministerial and Agency accountabilities with respect to our election commitments, the interim and final PESRAC recommendations and for the 2021 State of the State commitments to ensure there is absolute clarity in accountabilities. I advise that Heads of Agency performance agreements should be submitted to DPAC for my review by July 2021.

I will shortly be writing to you regarding a number of Premier's Priorities that will focus our collective attention over the course of this term. These priorities will include along with others, the areas of health, housing, skills and training and infrastructure delivery.

Portfolio Priorities

As an immediate priority in your portfolio area, along with the delivery of our election commitments, within the first six months of our term, I would like you to progress the Tasmanian Stadium Trust to oversee the development and management of major stadia across the State to maximise economic and community benefit for Tasmania.

Tasmania deserves to have its own Tasmanian teams in national competitions. The following draft documents were provided to you at the first Cabinet meeting of 19 May 2021 and are relevant to your Ministerial responsibilities. I urge you to familiarise yourself with the finalised documents and your obligations and responsibilities contained therein:

- Code of Conduct for Ministers;
- Code of Conduct for Ministers Guidance Notes:
- Code of Conduct for Ministers Receipt and Giving of Gifts Policy; and
- Tasmanian Government Lobbying Code of Conduct.

The Parliamentary (Disclosure of Interests) Act 1996 requires that all persons who become a Member, lodge a return with the Clerk of the Legislative Council within three months after the day on which the Member took the oath of allegiance. I note you have submitted a primary return and ask that you ensure your annual return is submitted on, or before, I October 2021.

Additionally, as you are aware, the Code of Conduct for Ministers requires each Minister to disclose to me any actual, potential or perceived conflicts of interest between their personal interests and their official duties. I would be grateful for your urgent advice, via return of the enclosed declaration, to me in relation to this matter.

Congratulations again and I look forward to your continuing success as a Minister as we work to improve the lives of all Tasmanians and secure Tasmania's future.
