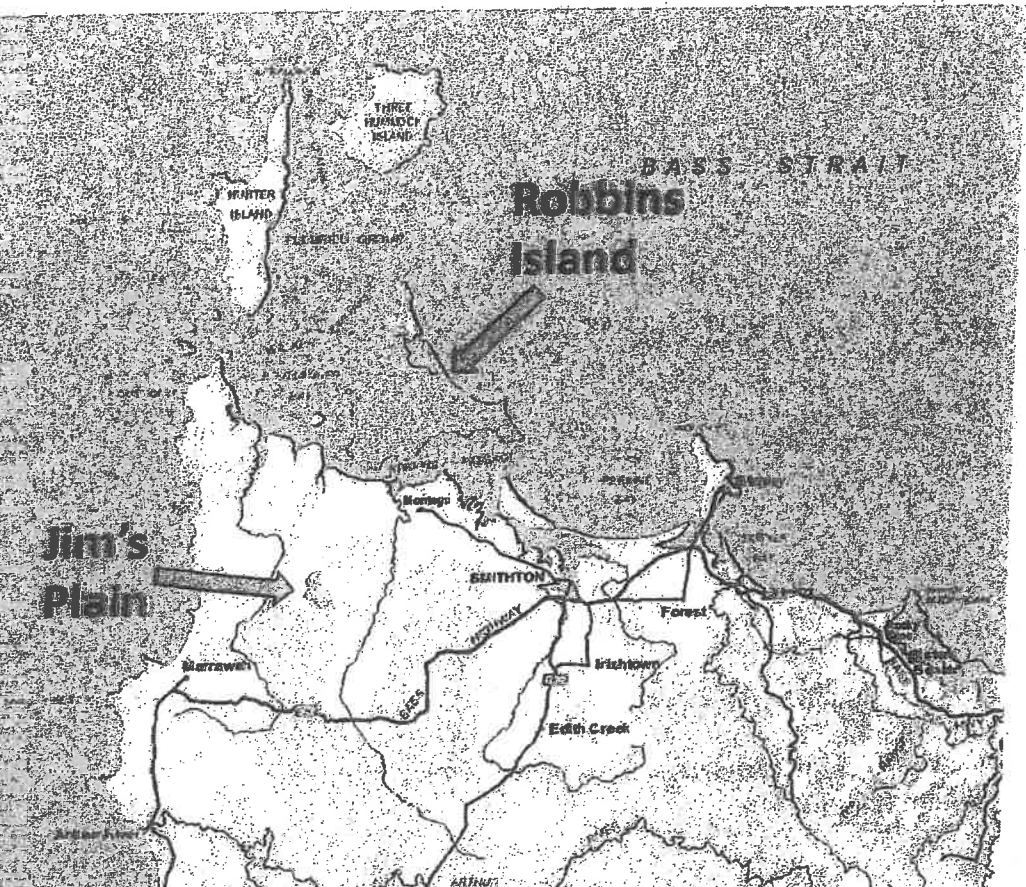
Hi I

## **Robbins Island Renewable Energy development project**

In early 2017 UPC Renewables Australia, an international developer of renewable energy projects, and the Hammond Family, freehold land owners on the north west coast of Tasmania, agreed to develop a Renewable Energy projects with an aggregate output potential of 600 MW to 1,000 MW on Robbins Island and nearby land.

The Robbins Island project is isolated and has one of the best proven wind resources in the world.

The project will complement the recently announced strategy for the Tasmanian Hydro system to act as south east Australia's power battery.

Further, the project is close to the Australian Energy Market Operator's proposed entry point to the second interconnector between Tasmania and Victoria.

Since 2000, investigations commenced into the feasibility of a large wind farm on the west side of Robbins Island (total 10,184 ha) and Jim's Plain (total 380 ha) and over the next 12 years, wind data, environmental studies and financial modelling were completed in preparation for lodgement of a DPEMP for both sites.

With a viable transmission solution available, Robbins Island could accommodate approximately 600 MW to 1000 MW of wind energy generation capacity with another 30 MW from Jims Plain.

Next steps are to lodge a DA (notice of intent commenced), stakeholder consultation, lodge connection enquiries (commenced) and applications and undertake further wind monitoring (about 12 months worth of work) and engineering works.

Expected cost of this work is plus \$3 million. There are no red flags for the project, except it will be highly dependent on the second interconnector (2IC). It is worth noting that the more renewables developed and exported over a second interconnector means the less Tasmanian end users have to pay for a 2IC.

The project is expected to employ 250 jobs during construction and 50 jobs when operational in the Circular Head area and be ready for investment by late 2018 / early 2019 – estimated value is \$1.6 billion.

UPC Renewables has established an office in Hobart.

UPC Renewables CEO Anton Rohner (Hydro Tasmania - GM Finance and Roaring40s - Managing Director, Asia) and COO David Pollington (GM Construction) are former Hydro Tasmania and Roaring 40s employees. Both participated in the development, construction and operation of Woolnorth and Musselroe projects in Tasmania and Australia/Asia (\$1 billion worth of investment).

Oliver Yates (the inaugural CEO of the Clean Energy Finance Corporation, a \$10 billion fund established by the Federal Government to reduce emissions in Australia)

has joined the company as an Executive Director. Oliver is regarded as a world leader in investing in carbon reduction and is well respected by both sides of politics.
