Purpose

1. For PSIRC to note Market Allowances that have been approved under *Employment Direction No 20*, *Application of Market Allowance* during the 2022 – 2023 Financial Year to date.

Recommendations

2. **Note** the Market Allowances that have been approved (refer to Attachment 1).

Analysis / Key Issues

- 3. Employment Direction No 20, Application of Market Allowance (ED 20) provides guidance on approval criteria and process to agencies for requests for Market Allowances for employees employed under the Tasmanian State Service Award (TSSA), Health and Human Services (Tasmanian State Service) Award (HAHSA) and Allied Health Professionals (Tasmanian State Service) Agreement 2012 (AHP).
- 4. Clause 6 of ED 20 states that a report will be provided by the Director State Service Management Office by 30 June each year outlining:
 - a. Approvals for each agency
 - b. Duties and nature of work
 - c. Allowance amount
 - d. Date of approval and review dates
- 5. For the financial year to date, six TSSA positions / employees have had Market Allowances approved, one in the Department of Justice, four in the Department of State Growth and one in the Department of Police, Fire and Emergency Management.



- 6. Additionally, while the Port Arthur Site Historic Management Authority (PAHSMA) is not subject to ED 20, the same criteria are generally used to considering a decision by the Employer to apply a Market Allowance to an employee or position.
- 7. One Market Allowance has been applied to a position in PAHSMA in the reporting period.
- 8. Market Allowances for other cohorts are not covered under ED 20 and are therefore not included in this report.
