



10-Year Salmon Plan

The Government is currently developing a 10-Year Salmon Plan that will commence on 1 January 2023, underpinned by the following principles:

• There will be no net increase in leased farming areas in Tasmanian waters:

An immediate 12-month moratorium is in place. There will be no net increase in total leasable area for fin fish farming in State waters beyond the current allocations and those areas subject to current research permits that may result in approved lease areas.

Innovation – future growth lies in land-based and off-shore salmon farming:

New research and innovation programs will be developed to support salmon farming further offshore in deep waters, including Commonwealth waters, and to increase salmon farming onshore, in land-based systems.

World-best practice through continuous improvement:

World's best practices will be ensured through continuous improvement in regulation and transparency, and fees and charges reviewed to ensure full cost recovery and an appropriate return to the Tasmanian community.

Strict independent regulation:

The separation of the Environment Protection Authority (EPA) from the Department of Natural Resources and Environment Tasmania will further enhance its role as the independent environmental regulator. Immediate additional positions will be created to support compliance, including a new Director of Fin Fish Compliance.

The Plan is being developed over 12 months, allowing industry and the community to identify new long-term actions that support a vision for a sustainable industry, and which continues to support Tasmanian jobs and businesses across the supply chain.

The draft project outline provides for multiple phases of consultation, including public meetings and the establishment of a dedicated forum.



Salmon companies, scientific institutions, non-government organisations, community groups, tourism, supply chain businesses, peak bodies, and different levels of government are all encouraged to take the opportunity to have their say.

It is anticipated an Issues Paper will be released for public consultation by mid-year - with further consultation to follow.

Tassal's Operations in other States

Tassal, in their 2021 Sustainability Report, reports operating two prawn farms in Queensland (Mission Beach and Proserpine), and one in New South Wales (Yamba), with other interests also in these States including an 'Aquaculture Development Area' (Exmoor Station QLD) and a 'Seafood Processing Facility' (Lidcombe NSW).

Additional interests include a 'Sales and Marketing' facility in Kew VIC, and in the Northern Prawn Fishery in the NT.

The report records harvest tonnage (HOG) of salmon for the FY2021 of 40 018 tonnes, and 3 919 tonnes of prawns.

Current Trading (domestic and international) for the salmon industry

The 2020-21 financial year estimated farm-gate value of the aquaculture sector totalled \$1.06 billion.

The value of salmonid production totalled an estimated \$1.0136 billion (based on financial reporting information supplied by companies to the ASX and Government).

There are indications that export trade to some countries has increased in recent months, noting that Tassal focuses on both the domestic (56% retail, 25% wholesale) and international markets (19% export).
