Subject: Tasmania's Australian of the Year- review of nomination process

I refer to the above, our recent discussions and my recent conversation with Brad Stansfield.

As previously discussed and based on my own research and discussions with the office of National Australia Day Council there are a range of concerns with the above which include the following:

- 1. The selection panel for the Tasmanian -Australian of the year, has a majority of mainland selectors over Tasmanian selectors-8 of 13.
- 2. Few nominations are received in the various categories.
- 3. Limited scrutiny and/or vetting of the nominees.

I am also advised that each state has the power to determine, at least to a significant extent, it's own selection process. Even if this were not the case it is important to ensure confidence in the selection process and questions exist regarding the current arrangements.

Accordingly I request a brief for the Parliamentary Liberal Party confirming or otherwise the concerns identified and providing further background as appropriate, and options to improve the nomination process. I will copy Brad with this email.
