

Ministerial Fleet Cars and Taxi Services Expenses and Associated Costs

The Government Ministerial fleet comprises vehicles that may be used by the Premier, Ministers, the Speaker, the Leader of Opposition and the Leader of the Government in the Legislative Council. When a Ministerial vehicle is not available, or if it is more efficient, taxis are used as a supplementary means for Ministers to undertake their business.

The expenditure below includes Ministerial fleet cars and Ministerial and Electorate Office Staff taxi services expenses (including Ministers' expenses), for the six-month period 1 April 2023 to 30 September 2023. Expenditure reflects when the expenses have been reimbursed and may not line up with the month the service was used.
