

Key Messages

- FortyTwo24 Pty Ltd (42-24) commenced operations on 1 July 2018
- 42-24 was established as a result of regulatory requirements under the Australian Energy Regulators Distribution Ring Fencing Guideline
- 42-24 offers telecommunications, data centre and information technology services previously offered by TasNetworks
- In line with business expectations, 42-24 is currently pursuing opportunities to deliver revenue growth and diversification opportunities

Background

In 2017, the Australian Energy Regulator (AER) developed the Distribution Ring Fencing Guideline (Guideline). The objective of the Guideline was to provide a level playing field for third party providers in new and existing markets for contestable services, such as those for metering and energy storage services, to promote competition in the provision of electricity services.

To avoid the above, the Guideline requires DNSP's to:

- 1. Legally separate any unregulated (non-distribution) services it provides from its regulated distribution services; and
- 2. Functionally separate any contestable electricity services it provides from its regulated distribution services.

42-24 does not currently provide any contestable electricity services, however it does undertake a number of 'other services' that require legal separation including:

- Telecommunications
- Data centre services
- IT Services (including laas)

Key Issues

The TasNetworks Cost Allocation Methodology is utilised for non-regulated activities to ensure there is no cross subsidisation from electricity customers.

This methodology was approved by the Australian Energy Regulator (AER) in June 2015 and subject to audit by our external auditors as part of the annual financial audit and regulatory submission processes.

To ensure overall compliance with the Guideline, 42-24 must submit an annual compliance report to the AER by 31 October each year, accompanied by an assessment of compliance by an independent authority.



Current Status

- As part of TasNetworks' strategic focus on growing un-regulated commercial opportunities,
 42-24 has been tasked with increasing profit and maximising returns to Shareholders.
- 42-24's technology division is seeking to grow its existing core services while expanding into the provision of cyber security and other opportunities associated with 5G and the internet of things
- 42-24 has also recently developed a whole of state digital twin called Virtual TAS in a joint venture with Enzen Australia. Using laser scanning and image capture technology, along with the ability to model and visualise big data, Virtual TAS will create a life-scale 4D map (known as Digital Twin) which will be used to help prevent and respond to natural disasters (eg. bushfires and flooding), guide remote rescue missions and guide new infrastructure and developments.
- The IT Services market is also currently experiencing a changing and competitive landscape and 42-24 needs to remain agile to compete and win business. Growing and acquiring key capability quickly is critical for this success.
- To assist in achieving these objectives, there is real opportunity for 42-24 to expand
 operations its technology and energy segments with a robust growth strategy. This strategy
 is focused on shifting the business from current to future state and involves strong growth
 in market presence, the types of products and services on offer, core capabilities, human
 resources and, importantly, financial metrics.

Next Steps

- 42-24's intention is to grow capability in technology services over the next 3 years. To
 achieve this, the business will focus on the Tasmanian enterprise and government
 technology sectors, with projects of strategic importance to the Tasmanian Government
 seen as a key priority.
- As part of this approach, 42-24 is currently recruiting personnel that can help achieve growth across both technology and energy services.
- Beyond organic growth, 42-24 will also be looking into merger and acquisition activity as a
 means to deliver more substantial growth and increase delivery capability (subject to
 Shareholder and Board approvals).
- 42-24 is uniquely positioned to service the State Government sector due to the scale and
 experience of its technology team. Additionally, there is currently a heightened level of
 focus on cyber security in the critical infrastructure space, so it is logical to collaborate to
 create a state based Cyber Security Operations Centre for Tasmania.

- 42-24 and Ernst & Young (EY) have been working together to co-design a strategic joint delivery model to deliver go-to-market cyber security services through 42-24 that drives profitable growth, supports the Tasmanian Government Cyber Policy and associated strategy and rapidly uplifts the future Digital and Cyber capabilities of TasNetworks, the State of Tasmania and the broader community.
- While some competition between 42-24 and other businesses is unavoidable, 42-24 is currently focusing on niches that have proven hard to create in Tasmania and therefore expects to compete with predominantly mainland based businesses. Importantly, 42-24 is open to conversations around partnering with local service providers.


Your office has requested that the Department of State Growth prepare a letter of support for 42-24 Pty Ltd's application under Round 3 of the Australian Government's Regional Connectivity Program.



This application will seek funding to upgrade telecommunications infrastructure connecting Cradle Mountain, Zeehan, Strahan, and Tullah from wireless radio technology to optic fibre. Specifically, each proposed upgrade will include:

- a new interconnection with TasNetworks' existing optic fibre
- the extension of new optic fibre over existing electrical distribution poles
- the establishment of a strategic point of presence within the optic fibre service area, allowing telecommunications service providers to connect their networks.

The upgrade will deliver faster and more reliable communications throughout the region. Maps of the proposed infrastructure at Strahan, Zeehan, and Cradle Mountain, are included at Attachment I.



42-24 has indicated that Hydro Tasmania will provide a co-contribution of \$200,000 towards new fibre to support its establishment of a 'workers' village' to accommodate workers needed for Battery of the Nation work being undertaken in Tullah.

It is relevant to note that 42-24's Round I project to upgrade telecommunications services supporting the Bisdee Tier Observatory were completed successfully, with a minimal delay of just two months.



Background:

The program

The Australian Government's Regional Connectivity Program is a competitive grants program funding the delivery of 'place-based' telecommunications infrastructure projects to improve digital connectivity across regional, rural and remote Australia.

The current Round 3 is being undertaken in parallel with Round 7 of the Mobile Black Spot Program (MBSP), to improve mobile and broadband connectivity in regional, rural and First Nations communities across Australia:

- a \$110 million Regional Connectivity (Round 3) stream for place-based solutions that deliver new or upgraded broadband services or upgraded mobile services in eligible locations across Australia and
- a \$50 million Mobile Black Spot (Round 7) stream that delivers new handheld mobile coverage to rural, regional and remote locations across Australia.

Applicants are strongly encouraged to consult with, and seek the support of, state and territory Governments in relation to their proposed solutions.

Applications for both the RCP and the MBSP close on Friday 11 August 2023.

The Tasmanian Government's participation in earlier RCP rounds

The Tasmanian Government has provided financial and non-financial support to several initiatives over both previous rounds:

• \$1.4 million to three initiatives under Round 1, including \$1 million for King Island transmission and mobile networks (completion expected by September 2023), \$150,000 for the 42-24 Bisdee Tier Observatory (completed June 2022) and \$261,000 for nine schools.

Three other Tasmanian projects were successful, including an NBN fibre extension from Franklin to Geeveston and Glen Huon, new small cells at Jericho and Lovely Banks (Midland Highway); and connectivity upgrades at the Tahune Airwalk and the Warra Ecosystem Observatory (TasmaNet).

 \$622,000 for four initiatives under Round 2, including \$185,940 for Deddington, \$179,928 for Royal George, \$217,275 for Lake Leake and \$100,000 for Pelham.



Several other projects were also successful, including four new Telstra macro mobile sites at Boat Harbour, Port Latta, Marrawah/Redpa and Lower Scotchtown and a fixed wireless network providing broadband coverage to the Cradle Coast agricultural precinct and neighbouring areas.

LETTER OF SUPPORT – 42-24 APPLICATION TO THE REGIONAL CONNECTIVITY PROGRAM FOR STRAHAN, CRADLE MOUNTAIN, TULLAH AND ZEEHAN

To Whom it May Concern

The Tasmanian Government supports 42-24's application for funding under Round 3 of the Regional Connectivity Program (RCP) to upgrade telecommunications infrastructure connecting the communities of Cradle Mountain, Zeehan, Strahan, and Tullah, from wireless radio technology to optic fibre.

The upgrades detailed in the application represent a transformational opportunity for the four communities and the almost 1,700 people who reside within them. Indeed, 42-24's extensive consultations with local communities and business have confirmed strong support for proposed solutions to the regions' protracted and challenging connectivity issues. The Tasmanian Government can also independently confirm the communities' keen desire for improved connectivity.

The new fibre infrastructure is expected to underpin the economic viability and competitiveness of the region's key employers, especially within the state's vital mining, renewable energy (including Battery of the Nation and wind initiatives) and tourism sectors. The four communities are all home to a diverse range of enterprises whose ability to drive productivity growth, or even maintain their competitive position, through new projects and innovations is seriously impeded by unreliable and congested connectivity. Connectivity shortfalls also impact the regions' ability to attract and retain staff, especially in times of labour scarcity.

Strahan, Zeehan, and Tullah are located on Tasmania's renowned, but relatively inaccessible, west coast, while the iconic Cradle Mountain is located in the remote central highlands. All four locations feature on Tasmania's increasingly popular tourist trail and host ever-growing numbers of visitors each year. Many of those visitors are attracted to the region's rugged mountain biking and walking terrain, isolation and challenging weather conditions.



However, those same attributes pose an inherent risk to both residents and visitors. Moreover, the region is at increasing risk of bushfire as climate change reduces rainfall and increases temperatures in these temperate forest regions. Reliable connectivity in such conditions is not only vital for the provision of localised emergency responses but is also essential to minimising emergency and network maintenance response times when additional support services must be sourced from other locations within the state.

In addition to facilitating economic and public safety gains, the proposed upgrades will also contribute very significantly to the health, education and well-being of residents in these remote and digitally marginalised communities, by supporting their ability to access remote health services and educational opportunities and participate in the increasingly digital life that metropolitan Australians largely take for granted.

EY are enabling 42-24 to deliver the solution locally for the Tasmanian market through cohesive operations with 42-24's own team, as well as through the delivery of cyber security training programs that support 42-24's vision to address the cyber security skills shortage in Tasmania.

As an example, 42-24 have recently hired two new Cyber Security Analysts, one of which is a Uni Grad, and the other an IT Service Desk Engineer looking for career advancement in cyber security who are currently undertaking training through our proficiency program (6 months). As we grow our client base for the solution, we will continue to hire and train new recruits to deliver 24x7x365 Threat Detection and Response (IRAP PROTECTED) services, with critical mass estimated at approx. 30 running the solution. We also work on career development plans with our cyber analysts to ensure they are supported in their career aspirations within 42-24, and welcome the opportunity for them to explore external roles to ensure we are injecting skills back into the industry.

42-24's team is also heavily engaged with the industry and associations such as TasICT, ACS and AISA, as well as TasTafe where our team has been involved in the shaping of the Cert IV in Cyber Security with the AIG group to further skills and development in the sector.
