Good morning Chris,

As I believe you are aware, the Cartela Trust has recently had discussions with Ms Lara Hedriks from the Premier's office in regard to the Cartela Restoration project, changes to the location where the Trust intends to undertake restoration of Cartela, and the best way to access the \$1m grant offered by the Premier in February this year.

In short, following detailed investigation conducted following our earlier meeting in Hobart, it is clear that undertaking restoration at Franklin through building and locating a ship lift as part of a wider Maritime Heritage Precinct is not a viable option.

After further investigation, including discussions with Mr **NR** **s 36** and his Battery Point working group, the Trust has resolved that the best option is to undertake restoration at Battery Point, and to be part of **s 36, NR** vision for a Maritime Heritage Precinct at that location.

It is proposed to relocate Cartela to a slip way at Battery Point following its upgrade to suit the restoration task. Attached is a letter from the slipway owner **s 36, NR** confirming his willingness to allow his slipway to be used for this purpose for a minimum period of 2.5 years, or as long as necessary.

Also attached as a first step in the project is a quotation from Burbury Consulting Engineers to review the slipway and provide a report on remedial action and costs to bring it to a necessary standard to hold Cartela and allow restoration.

In view of the importance of Battery Point to Hobart's history, and the slipway and workshop area in particular, the Trust is keen to establish a strong partnership with the Hobart City Council (HCC). Initial discussions between the HCC and **NR, s 36** and his working group (at which it was acknowledged that restoration of Cartela was a key component of the vision), the HCC expressed strong support for the project.

In light of discussions the Trust has had with Ms Lara Hendriks, and in accordance with her discussions with officers from the Department of State Growth, a Restoration Plan with Milestones, timeframes, and estimated costs has been prepared and is attached.

Also attached is:

1. A letter from **s 36, NR** confirming that his slipway at Battery Point is available for the restoration work on the Cartela for a minimum of 2.5 years.
2. A quote from Mr **s 36, NR** of Burbury Consulting for the analysis of the state of **s 36, NR** slipway, and provision of pricing for slipway remediation as a first step in commencing the project.
3. A previously prepared Campaign Plan.

The Trust looks forward to working with you to develop a Grant Deed to allow the project to commence as soon as possible.

The Tasmanian Government recognises the important maritime history of the Cartela and the tourism potential of seeing her restored. My government has approved a grant of \$1 million to the Steamship Cartela Trust to assist with her restoration.

The Trust is a volunteer organisation which was established for the sole purpose of promoting the restoration of the Cartela. The Cartela was donated to the Trust by the Navigator Group of companies.

The Department of State Growth has been working closely with the Trust to determine how the grant funding can best be utilised to progress her restoration.

Given the age of the Cartela and her wooden hull, the restoration process is complex. I can assure you that the Trust is making progress towards a solution and recently provided the government with a proposal that will hopefully see her restoration commence soon.

I understand that State Growth's Senior Commercial Manager, Chris Cooper, has contacted you directly to discuss your queries. Chris will contact you again when the trust is able to make a public announcement regarding next steps in her restoration.

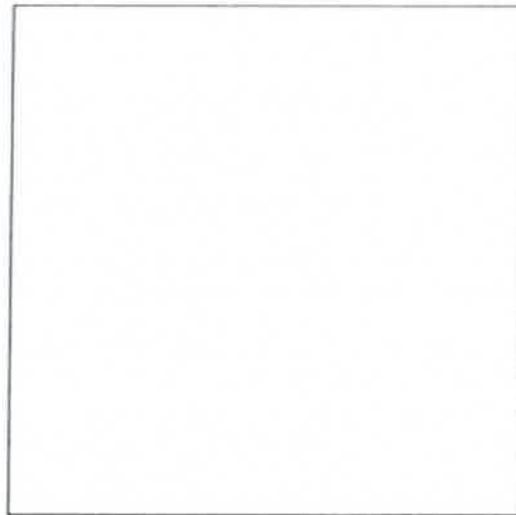

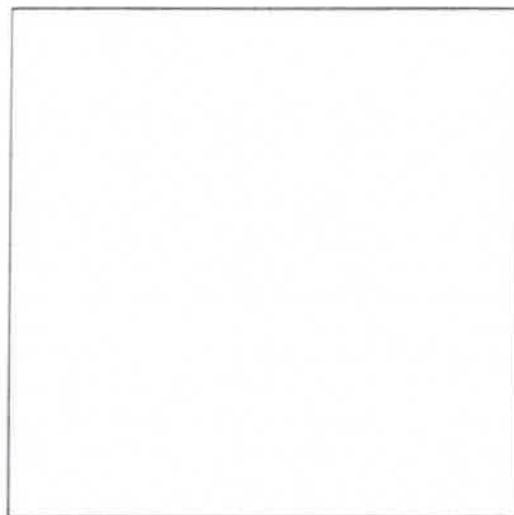
